They will have experience in global stakeholder engagement and proven ability to identify, develop and leverage relationships for a strategic purpose. The ideal candidate will bring passion for and determination to achieve the vision of clean air for all. They will have a naturally collaborative approach, and the ability to build, lead and manage teams. Experience and knowledge of air pollution, public health, childhood development, or climate change is desirable.

Most importantly, we are seeking a self-starter, comfortable working at pace in a startup environment with highly developed communication and influencing skills.
